Circular to Members

In respect of

JWC Hull War, Piracy, Terrorism and Related Perils Listed Areas—JWLA-028

To: All Marine War Risks Members,

Dear Members,

This Circular is issued to the members who have entry with the Association for Marine Hull War and Strike risks insurance covers. This English Version Circular is an interpretation to the Chinese Version Circular and in case of any discrepancy between the two versions, the Chinese Version shall prevail.

Your Managers refer to the Association's Circular in respect of War Risks Trading Exclusions No.22/2021 dated 6 May 2021 and as members have been aware that following a review by the Joint War Committee (the JWC) and in consideration of a potential escalation and possible military conflict in and around Ukraine, the War Risks Trading Exclusions (the Hull War, Piracy, Terrorism and Related Perils Listed Areas) have been recently amended as follows, and consequently, a new list (JWLA-028) was issued by the JWC on 15 February 2022:

Added:

Ukrainian and Russian Waters in the Black Sea and the Sea of Azov

Accordingly, the Association, in accordance with applicable Notice of Cancellation Clause and relevant provisions contained in the Association's Rules and other similar provisions as may have been contained in the entry terms, hereby tender this Notice of Cancellation in order to revise the navigating limits and exclusions to incorporate the JWC Hull War, Piracy, Terrorism and Related Perils Listed Areas dated 15 February 2022 (JWLA-028), a copy of which is enclosed.

In this regard, all members having War Risks entry with the Association should bear in mind that this Notice shall run for 7 days, from 19 February and expire at 23:59 hours GMT 26 February 2022 with members' War Risks Covers incorporating the War Risks Trading Exclusions No.22/2021 dated 6 May 2021 being cancelled but automatically being reinstated with JWLA-028 dated 15 February 2022 being applied from 00:00hours GMT 27 February 2022.

In the absence of notice in writing having been received from members prior to the expiry of this Notice,

- (i) members shall be deemed to have agreed to such amendment of the said listed areas;
- (ii) the War Risks Covers will be automatically reinstated upon expiry of this Notice subject to such amendment of the said Listed Areas, and:-
- (iii) such amendment shall be deemed to have been endorsed upon and form part of the members' entry terms of War Risks Covers with the Association.

Where the Listed Areas applying to the entry terms with the Association prior to this Notice have been the subject of any deletion amendment limitation or restriction, such deletion amendment limitation or restriction,

- (a) shall continue to apply mutatis mutandis to the new listed areas, but
- (b) shall not apply to any port(s) and/or place(s) and/or area added in consequence of this Notice.

Furthermore, as a matter of War Risk Covers with the Association, the reinstatement of the agreed excluded countries/ports/areas prior to this Notice for the respective Members insurance cover shall continue upon expiry of this Notice.

Notwithstanding the foregoing, should the insurance cover already be subject to trading warranties limiting the area of trading as per individual member's specific entry terms, any port(s) or area to be added in consequence of this Notice would not in any case have been a permitted port(s) of call or area of trading, the insurance shall not be subject to this Notice.

Members are kindly reminded that with the application of this new War Risks Trading Exclusion, if any of their vessels intend to perform a breach voyage, which give rise to a need of cover extension to any port(s) or area(s) of the new listed areas, a prior notice (at least 48 hours prior to arrival of any excluded area) shall be given to the Association. War risk covers will be reinstated but subject to any additional premiums and revised terms and conditions as may be offered by the Association.

Details of the Listed Areas (JWLA-028) which applies with effect from 00:00 hours GMT 27 February 2022 can be found at the enclosure.
